What are your data protection rights?

The right to rectification – You have the right to request that Velocity Flight Training Limited correct any information you believe is inaccurate. You also have the right to request Velocity Flight Training Limited to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Velocity Flight Training Limited erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Velocity Flight Training Limited restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Velocity Flight Training Limited's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Velocity Flight Training Limited transfer the data that we have collected to another organization, or directly to you, under certain conditions.
